The sole issue on this appeal by William Lee Bentley, a felon, is whether the district court erred in overruling his motion to suppress evidence seized from his jacket pocket during a pat-down search. We find no error and affirm. On December 16, 1988, Officer John Moeller of the Iowa City Police Department saw Bentley walking in the street. The officer knew Bentley as a juvenile offender for whom he had arranged the placement of a tracking device. Consequently, when Moeller saw Bentley, he asked for and obtained Bentley's identification. Moeller then ran a warrant check and learned that Bentley had been adjudicated delinquent as a juvenile for burglary. On this occasion, Moeller decided to issue a citation rather than an arrest. He returned to his patrol car and asked Bentley to remain on the street while he prepared the citation. Moeller then retrieved the paperwork necessary to fill out a citation and began to ask Bentley about his destination and destination plans. While engaged in this conversation, Moeller received a radio communication stating the *710 police had been summoned to the apartment of one of Bentley's friends, where there had been a disturbance with a pistol. Moeller then retrieved the weapon used in the incident and returned to Bentley, who by this time was walking away. Moeller asked Bentley if he had a gun and received an affirmative response. Moeller then frisked Bentley and found a knife concealed in his pocket. He arrested Bentley, handcuffed him, and then read him his Miranda rights. At trial, Bentley moved to suppress the
